## Airtel-Vodafone Apple product gift offer Terms and conditions

The Airtel-Vodafone Apple product promotion terms and conditions should be read in conjunction with the Airtel-Vodafone general Pay monthly or Post-paid terms as highlighted under the terms and conditions links on [www.airtel-vodafone.com](http://www.airtel-vodafone.com). Where there is conflict between the Airtel-Vodafone Apple product promotion Terms and Conditions and the general Airtel-Vodafone Pay monthly or Post-paid Terms and Conditions, the specific Terms and Conditions from the Airtel-Vodafone Apple product promotion terms and conditions shall apply, but all other provisions within the general Airtel-Vodafone Pay monthly or Post-paid Terms and Conditions shall remain in full force and effect.

### Promotion rules:

1. This promotion is available to any new pay monthly customers porting their mobile number and / or taking out a new monthly contract with us.
2. This promotion is only available to existing pay monthly customers if they have completed their existing Airtel-Vodafone pay monthly contract. They can renew their monthly contract by taking up one of these new promotional offers.
3. Promotion is only valid on new pay monthly contract of £30 and above plans on a 13, 19, 25 and 30 month period contract.
4. At time of sign up, the customer can opt to take a free handset at no extra charge as part of the promotion. This free handset will be from a selected range of handsets. The customer can also opt not to take this free handset from the selected range, and pay more money as a one time payment for a higher priced handset. This price will be determined by Airtel-Vodafone store staff at time of sign-up.

6. All issues related to Apple devices shall be directed to and dealt with by the iQ store and covered under Apple warranty for repairs and / or replacement. No customer shall be able to return any Apple item redeemed from the iQ store at the Airtel-Vodafone store.

8. Any customer who decides to churn during the contract period will be subject to standard early contract termination charges.
9. All sign-up must be started and completed at the Airtel-Vodafone store in Jersey or Guernsey. Any customer who comes to the iQ stores intending to sign up shall be directed to the respective Airtel-Vodafone store to port/take a new contract and get iQ vouchers.
